## I. Purpose

This Agreement defines the terms and conditions under which the Buyer agrees to purchase and JAAW EQUINE agrees to deliver fresh chilled semen of the approved stallion, OBELIX REN, to breed to the mare, \_\_\_\_\_ to produce one foal. Obelix Ren is lifetime approved AES, Danish, Westfalen; foals can also be registered KWPN-NA REG A, and AHS.

Stallion: Obelix REN

Pedigree: Just Wimphof x Krack C x Farrington

Per Dose Fee LFG: (Fresh/Cooled) #: \_\_\_\_\_ \$1,000 (\$500 non-refundable deposit)

Collection and shipping fee: \$450

## II. The Mare

- a. A veterinarian must administer the semen within twenty-four hours after receipt.
- b. Buyer acknowledges that the mare is of sound health and breeding condition.
- c. Embryo transplants are permitted under the terms of this agreement. Buyer is responsible for paying a Stud Fee for each successful embryo. Buyer must indicate their intent to perform embryo transplants at this time.
- d. This agreement includes a 'Live Foal Guarantee'. The agreement will continue until a live foal has been produced. There is no limit on breeding cycles. A live foal is defined as a foal that stands and nurses within twenty-four hours after foaling. In the case of the foal's death, the Buyer must verbally notify JAAW Equine within forty-eight hours followed by a signed certification by a veterinarian within five days.

## III. Fees

- a. All payments are due before semen is shipped.
- b. Flat fee of \$450 for collection and shipment payable to JAAW Equine. Discounted fee for Buyers who pick up semen at Coalcyn Equestrian.
- c. Contract type:
  1. Standard Fresh Contract with LFG (Live Foal Guarantee): \$500 booking fee and \$500 due before the first collection request. Collection and shipping due before collection. Live foal guarantee once contract is fully paid.
  2. Fresh contract, one dose, NO LFG: \$850 flat fee plus collection and shipping.

#### IV. Requesting Collection and Shipment

- a. Buyer must notify JAAW Equine at the beginning of the heat cycle that they are planning on breeding. Collections are made 5 days/week, Monday-Friday. In order for semen to be collected and shipped for timely arrival, it is the Buyer's responsibility to communicate semen requests to Adrian Ward at 801-699-1912 the day before the intended collection.
- b. When the shipment has been received by FedEx JAAW Equine will share the tracking number with the Buyer. Orders canceled after the stallion has been collected will be billed. JAAW Equine and Coalcyn Equestrian assume no responsibility for the loss of semen or semen viability caused by the carrier.
- c. The Buyer understands that each shipment of semen will contain one dose of semen. A second dose will be included in the shipment only after all orders are filled and additional doses are still available. Priority will be given in the order the contracts were received.
- d. Mare Owner shall have no right, title, or interest in the stallion. The breeding season for the stallion via fresh semen is March 1, 2025, to August 15, 2025 with per case exceptions possible.

#### V. Terms of Termination

- a. The term of this agreement shall commence on the date of receipt of payment from the Buyer. The agreement concludes when a live foal has been produced or there are significant changes made to these terms.

#### VI. Death, Unfitness or Sale of the Stallion

- a. The fees paid or incurred under this agreement are nonrefundable. In the case of the death or unfitness of the stallion, contract will be fulfilled with high-quality frozen semen.

#### VII. Miscellaneous

##### a. Assignment

1. This contract can only be transferred to another Buyer or mare with written permission of the Stallion Owner, provided no shipments have been received and \$100 mare transfer fee.
2. The terms of this agreement shall be governed by the laws of the State of Utah

##### b. Breach

1. Either party may nullify this agreement if the other party breaches a material term of this agreement. The wronged party may recover reasonable attorney's fees and court costs.

C. DISCOUNTS:

1. 10% for FEI mares, mares with elevated status within respective registries, or USEF third level equivalent or better offspring (separate form must be filled out).
2. 10% for multiple mare discount for same Mare Owner mares.
